

SPIS NAJWAŻNIEJSZYCH NABYTEKÓW BIBLIOTEKI INSTYTUTU BAŁTYCKIEGO

W numerze niniejszym Spisu rozszerzono ramy chronologiczne, sięgając także wstecz, poza 1939 r. Materiał ugrupowano w wyliczonych poniżej działach, w obrębie piśmiennictwa morskiego zastosowano dalszy podział logiczny. Nierównomierna ilość materiału i niecelowość tworzenia zbyt drobnych grup spowodowała czasem niedostatecznie precyzyjny przydział. Mimo to, wobec niezbyt obfitego materiału, mamy nadzieję, iż nie sprawi to większych trudności.
